	Pou 1- Te Tiriti O Waitangi – Dorothy reviewed it against it the RN one – Feel 1.5 reads better than EN 1.1 Suzanne explained – to delete off the RN one. 1.2 – instead of recognises use word "understands" 1.5 - should be reworded – "Develops an awareness & ability to use Māori models of health" 1.6 - Should be under Pou 2 – cultural safety	
	Pou 2 - Cultural Safety - How is it measured – what is a diverse population/what who is	

priority.

Statement to add in "this domain contains competencies to ensure cultural safety in practice, this requires EN to reflect on own values, biases and beliefs, to deliver care to all cultures, beliefs and backgrounds"

2.1 – the definition in glossary needs to be expanded to include/name the other priority groups – if not other priority groups to be named then needs be removed from 2.1

2.4 - can be moved into Pou 4

## Pou 3 - Knowledge Informed Practice

- 3.2 remove "where appropriate" is restrictive
- 3.5 Change Whanau and replace with Whakapapa
- 3.6 combine with 3.7 to read "applies knowledge of medications, recognising side effects and adverse and demonstrates the principles of safe and effective administration of medicine in accordance with legal obligations" remove 3.7.
- 3.8 should also add "applies with infection prevention and controlled principles in accordance with evidence-based practice" and to become the new 3.7 and remove 3.8

## Pou 4 - Professional Accountability and Responsibility

- 4.2 add in NCNZ code of conduct
- 4.3 remove breach of nurse's privacy and also subjective
- 4.5 Take out "a culture of safety and"

## Pou 5 – Partnership and Collaboration

- 5.1 add "safe and effective care"
- 5.3 Add in "collaborates with individuals, careers, MDT along side whanau"
- 5.5 important competency to have but does it belong in Pou 5. To remove "to maintain care and reduce risk as appropriate". Move to Pou 4.
