- using professional nursing workforces, to access, engage and deliver consumer education and provide a vital link between consumers, their whānau and other clinical, medical and funding services.

NZNO wishes to draw to your attention the role of nurses as the key interface and advocate for consumer participation and recommend the inclusion of nurses as a key health professional to be involved in further discussions about improving consumer participation and education.
