NZSSD Annual Scientific Meeting & Special Interest Group (SIG) study days

The NZSSD scientific meeting is on 14 and 15 May this year. It is shorter because of the possibility of a change in Covid alert level which obviously can impact attendance and finances adversely. It is also on over a Friday/Saturday too in response to previous feedback.

The SIG study days are being split into virtual webinars on the first Wednesday of the month. The first one will be in May and will cover the new T2 guidelines and medications. Timing will be decided based on feedback from an email you will have received asking for your preference.

This will be a great opportunity for us to attend presentations from the other disciplines such as registrars,

psychologists and dietitians. And fabulously these will be free for NZSSD members. For non-members the cost will be the same as an NZSSD membership fee so people can join and get good bang for their buck.

T2DM Guidelines Updated

The days of advice to call a specialist if the patient needs to start mixed insulin are over. The new T2DM guidelines from the Ministry of Health and NZSSD are hosted by NZSSD at https://t2dm.nzssd.org.nz/

There is a wealth of information which is easy to find. One of the biggest changes is the addition of the SGLT2is and GLP-RAs as 2nd line treatment and a recommendation to encourage use of the other as 3rd line treatment even though one of them wouldn't be funded.

Other big changes include weight based starting doses for basal insulin which leads to much bigger initial doses and starting meal time insulin when the patient is on a basal dose of 0.5 units/kg. Most of us have seen patients on way higher basal doses without bolus insulin. There is also a suggested correctional scale.

Maybe with the new medications people won't need to move onto bolus insulin any more...

Prescribing in Diabetes and Related Conditions Meeting

Thanks to Vicki McKay, long term conditions nurse at THINK Hauora in the Manawatu for this report:

The Diabetes and Related Conditions Prescribers Conference was held in Wellington on 10 & 11 March. Over 85 delegates attended the conference – 2021 marks 10 years since the first Nurse Prescribing in Diabetes program. There were a variety of speakers and topics, from hypertension, thyroid disorders, women's health to drug funding, and the new NZSSD Type 2 guidance.

Take home messages included annual thyroid function testing for PWD due to increased likelihood of thyroid disorders; the use of weight-based calculations for T2DM starting doses; although SGLTi & GLPRA are not funded together, if indicated patients could self-fund the SGLTi (approx. \$85 per month).
