

Financial Report 2025 Annual General Meeting College of Emergency Nurses of New Zealand - NZNO

The overall income for the financial year 2024/25 was \$236,559 with total expenses of \$202,837 resulting in net surplus of \$33,722.

The 30th CENNZ conference will be held in Auckland in March 2026. Financial report for this will be reflected in the 2026 Annual General Meeting.

Sixteen triage courses were held in 2024/25 with 330 attendees, achieving a total net \$187,922.75 with total expenditure of \$125,678.87 resulting in net surplus of \$62,243.88. The main costs were for air travel, accommodations and meals.

Education activities total income was \$4,910.61 with total expenditure of \$19,372.18 resulting in net deficit of \$14,461.57. Over time education activities have increased with active participation from networks of Nurse Managers, Nurse Practitioners, Nurse Educators and Advanced Emergency Nurses including ministerial engagements. Due to external factors of workplace pressures, the difficulty in organising network meeting, expenditure has decreased on this front comparative to the 2023 /24 year.

CENNZ committee meetings and administration total income was \$41,467.10 with total expenditure of \$56,987.30 resulting in net deficit of \$15,520.20. Majority of expenses were air travel, accommodation and meals.

The 2024/25 financial year has maintained a stable financial status. CENNZ ended the financial year on 31 March 2025 with cash at bank (including term deposits) totalling \$367,640.80.

Moving forward, CENNZ treasury will continue to focus on a sustainable budget to assure a deficit is not recurring year on end. These measures include advance flight bookings through flexi fares for meetings and activities, utilisation of triage instructors to deliver teaching within the vicinity and ongoing provision of triage courses and membership registrations. Exploring further options on expanding our key work is ongoing. CENNZ treasurer will continue its commitment to deliver robust financial planning and withstand the economic inflation in Aotearoa New Zealand.
