We have continued to meet with stakeholders at our face to face meetings, which have included NCNZ, MOH and NZNO.

NZNO

Collective Agreement

As you are aware the Te Whatu Ora collective agreement will expire on the 31st October 2024. I am pleased to advise you all that there has been two Enrolled Nurses selected for the bargaining team. I wish them all the best. Claims meetings have already been held throughout the workplaces. Claims that are being put forward that were not addressed in the last round of bargaining are as follows,

Safe Staffing, Actualising te Tiriti, Health and Safety, Pay Claim, Senior Nurse/Midwife wage scale review and any other additional claims that may be put forward. Thank you to all the

bargaining team for their continued Mahi, we know you are all doing your best to achieve the best outcomes for all health workers.

NZNO AGM and Conference:

NZNO AGM and Conference was held back in September at Takina, Wellington, Myself and Melissa attended to represented the Enrolled Nurse Section. Day one was the NZNO AGM and Day two was Conference Day. The theme for conference was *Together we are the Leading Voice of Nursing*. We undertook in activities based on Challenges for Maori within the Aotearoa Health System.

NZNO COLLEGE AND SECTION DAY 2024:

College and Section day was held in Wellington on the 4th/5th March. Both myself and Debbie attended to represent the Enrolled Nurse Section. This was a successful two days with presentations from Paul Goulter, Anne Daniels and Kerri Nuku who outlined the foucus on Colleges and Sections and an overview of the NZNO work over the past year. Paul Goulter Highlighted the importance of the college and sections to represent their specialty, he also challenged us to grow in membership numbers, lift member involvement and influence and to consider any barriers which may need to be addressed to enhance their Mahi. We had the opportunity to share our key achievments and future aspirations, see powerpoint ..\..\.\.\EN Section Presentation CS day 2025 (3).pptx. We also had presentations on New membership Database and Reporting, Comms support and media training, Resisting deregulation whats at stake in the review of the HPCA Act. We also did a networking session with just delegtes from college and sections. This was an opportunity for us to give NZNO feedback of what we wanted from them.

NCNZ - ENROLLED NURSE SCOPE OF PRACTICE REVIEW:

The milestone for the Enrolled Nurse section this year is the introduction of the new "Scope of Practice" for the Enrolled Nurse. The Committee and design group have worked closely with Nursing Council on this. We have also had input into the new competencies and the educational standards that have been developed as well. Our opportunity to work independently in the health care team — without those words that EN's have struggled with for years "under the direction and delegation of the Registered Nurse" has now gone. So, a new chapter begins for us.

This work is now completed and came into effect in January 2025. It will be implemented over time with full implementation January 2026. Thanks goes out to all those involved in this Mahi.

MOH – PUTTING PATIENTS FIRST:

MOH have put out this document which totally undermines the nurse's role. They are putting political mandates ahead of public safety. It is imporant that all nurse's fight back

against the attack on public safety. NZNO see this as a overreliance on inqualified health workers displacing nurses in all areas.

ENROLLED NURSE SECTION NZNO, ENROLLED NURSING MARKETING STRATEGY:

This is still work in progress by the Enrolled Nurse Section NZNO National Committee and we have been working with the NZNO Communications and Media Advisor Neville to start progressing forward with this. We are currently exploring options for setting up a website. Glenda has nominated the EN Section to be the guinea pig/first cab of the rank for the College and Section website upgrade. We will be able to have input into the design, layout and details that go onto it.

ENROLLED NURSE POSITIONS WITHIN NEW ZEALAND

These continue to be advertised, with new employment oportunties opening up for enrolled nurses across New Zealand. These opportunities are not only within Te Whatu Ora but in Aged Care Facilities, Community and Primary Health.

DIPLOMA OF ENROLLED NURSE PROGRAMME

Otago Polytechnic Te Pukenga – 30 students started this year, 30 sitting state in July Southern Institute of Technology - 14 students started this year, 14 sitting state in July Ara Te Pukenga Canterbury - had 60 students started this year, 53 Sitting state in July Northtech - had 12 students start this year, 16 sitting state in July

ENROLLED NURSE SECTION NZNO AWARD TO A GRADUATING ENROLLED NURSE FROM EACH POLYTECHNIC IN NEW ZEALAND

"Demonstrating Leadership Skills" is the Enrolled Nurse Section NZNO National Committee award given to a new enrolled nurse graduating from our Polytechnics throughout New Zealand each year. Most of our regional enrolled nurse sections also give an award at each graduation and gifts to all the enrolled nurse graduates. Graduating ceremonies have occurred at Northtec, Ara, Otago Polytechnic and Southern Institute of Technology.

MEMBERSHIP OF THE ENROLLED NURSE SECTION

Our current membership is sitting at 696. We have had a slight increase in numbers since the same time last year which was 660. We are working with Neville currently to establish a website and also working with NZNO on ways we can increase our membership. We are hoping to capture the students who have started the Diploma this year to join the section.
