What is "Scope of Practice"?

A scope of practice is a broad description of the role associated with the educational preparation and level of the nurse. It is provided as a foundation for establishing standards of nursing practice, nursing education, nursing roles and responsibilities, and is defined within the legislative and regulatory framework of the country in which the nurse works (ICN, 2013).

International themes:

- Wide variety of approaches to define scope
- Highly variable with Managers being key decision makers (often restrictive)
- Confusion about scope in the HC team
- Desire for task lists and guidelines
- EN use higher where policies support a broad Scope

Background to the Scope change

Timeline

The proposed changes to the EN SoP reflected NCNZ's desire to modernise the current scope statement:

- clearly recognising commitment to and the position of Te Tiriti o Waitangi
- reflecting more breadth of practice in the scope statement
- removing specific prescription of tasks
- better reflecting the appropriate position of Enrolled Nurses with respect to Registered Nurses and other practitioners

3 parts to NCNZ regulation – are we there yet?

- Scope of practice statement achieved
- Endorsed and launched for gazetting in 2024
- Prescribed education qualification halfway
- New education standards released for consultation 4 December
- Aim for introduction mid 2024
- Accreditation against the standards 2025
- Enrolled Nurse Competencies drafting is almost completed
- Currently being drafted alongside the RN competencies
- Consultation till February 2024

NZNO feedback re draft Scope Statement

- Support for proposed EN statement
- Support for removal of D&D
- EN Title: Not NZNO role to determine title
- ENs are a valuable part of the health workforce and these changes enhance their knowledge and skills and offer new opportunities and challenges.
- Gains for ENs and the health sector

Other feedback on the draft scope

Questioning of the change to EN Scope prior to changes to RN Scope

Strengths:

- Kawa whakaruruhau framework
- Working in partnership and collaboration
- Acknowledgement of education and training

Weaknesses or potential risks

- Current statement could be open to interpretation by employers and ENs placed in situations outside of their educational preparation.
- No clear differentiation between this and the RN scope.



Final Endorsed Enrolled Nurse scope of practice

Enrolled Nursing in Aotearoa New Zealand reflects knowledge, concepts, and worldviews of both tangata whenua and tangata tiriti. Enrolled Nurses uphold and enact Te Tiriti o Waitangi ngā mātāpono — principles, based within the Kawa Whakaruruhau framework for cultural safety that promote equity, inclusion, and diversity.

Enrolled Nurses are accountable and responsible for their nursing practice, ensuring all health services they provide are consistent with their education and assessed competence, legislative requirements, and are supported by appropriate standards. This includes the right of Māori and other population groups to quality services that are culturally safe and culturally responsive.

The Enrolled Nurse works in partnership and collaboration with the health consumer, their whānau, communities, and the wider healthcare team to deliver equitable person/ whānau/ whakapapa-centred general nursing care, advocacy, and health promotion across the life span in all settings. - Standard Two: Safe care for the public
- **Standard Three:** Academic governance, leadership, and partnership
- **Standard Four:** Programme of study EN/RN schedules
- Standard Five: Ākonga/Student experience
- Standard Six: Ākonga/Student assessment
- Standard Seven: Emergency events



Consultation – Specific changes

- Pg 27-28
- Changes to credits and qualification level
- Reduction in clinical hours
- Simulated learning
- Recognition of prior learning
- Ability for ENs to sign off assessments



What does a competent enrolled nurse look like?



- Professional standing
- Equity and Pae Ora Act (Healthy Futures), Te Ao Māori, Kawa Whakaruruhau, Cultural Safety, te Tiriti o Waitangi
- Attributes diversity and inclusion
- Accountable for practice decisions, omissions and actions, conduct
- Assures the public of competence
- Practises in challenging and adapting contexts
- Is positioned into the future climate change and social determinants of health – Sustainable development goals

What is a competent Enrolled Nurse? elements to cover (resist the list)

Trusted by the community (public protection HPCAA) Positive aspects of being a regulated practitioner Pae Ora and Equity
Understanding and working
within te Tiriti o Waitangi

Cultural safety demonstrated in practice inclusive of Kawa whakaruruhau

Demonstrates ethical decision-making frameworks
Understands social

Understands social determinants of health and social justice principles

Has the knowledge and skills which provide improved health outcomes

Understands the application of the EN Scope of Practice
Practice at top of scope

Clinical judgement and decision-making to inform assessments, interventions and prioritisation of care

Decision-making and the ability to refer on when appropriate

Assessment of deterioration and escalation pathways

Understanding of emerging diseases, population health and public health

Contributes to the changing practice environment – climate change and sustainability; social changes

Health and Safety, infection control, safe Handling, violence and aggression

Time management
Team work
Cohesion

Communication – health team, Whānau, Consumer, whanaungatanga (building relationships). Meet the unmet need for whanau

Patient education and Health education

Able to mentor and preceptor those undertaking nursing education

Participates in Continuing competence opportunities
