College Work

Members will be aware of the recent revised Nursing Council Competencies review. This was discussed in depth at our February meeting. The College prepared a submission that was sent through by Bridget to NCNZ and raised concerns about the number of Mcompetencies, the detail of some of the new ones, and the articulation between the RN and EN scope of practice.

There has also been work on the Age Safe campaign, and Aloha and Bridget recently has attended the College and Sections Day, with a report to follow in the next newsletter.

Clinical Update: Aged Care Commissioner Report

As mentioned earlier in the newsletter, Carolyn Cooper, Aged Care Commissioner released her report on insights into Aged Care. The report, *Amplifying the voices of older people in Aotearoa New Zealand*, has been informed by the voices of older people, their whanau and communities, as well as insights from service providers and agencies that work with older people. It provides a snapshot of the issues and challenges faced by older people using health and disability services in Aotearoa New Zealand, and focuses on the need for an integrated continuum of care that concentrates on prevention and support.

The report considered the following critical insights:

- The need for better transitions of care for older people from hospital to home and community support services and aged residential care
- Investing in innovative primary and community care models, including assisting older people to navigate health and disability services
- Preventative interventions for dementia mate wareware, and:
- Ensuring that people can access reliable, quality HCSS services to age well at home.

Clinical Update: Anticholinergic Medications and Burden

Older people, particularly those who are frail and with multiple morbidities, are most susceptible to the cumulative effects of medicines with anticholinergic activity, leading to adverse effects such as cognitive impairment and falls. Key practice points include:

- Anticholinergic burden refers to the cumulative effect of taking medicines with anticholinergic activity. These include antidepressants, antiemetics, antipsychotics and oxybutynin.
- Let's Talk Medicines
- There are a range of adverse effects that can occur with these medicines, and are generally dose dependent. They include effects such as drowsiness, impaired concentration, agitation, hallucination, delirium. There are also peripheral effects such as dry mouth,. Pupillary dilation, sweating, tachycardia and constipation
- Long term use of these medications are associated with reduced mobility, cognitive impairment and development of dementia
- Older people are at higher risk due to age related changes in physiology, and increased likelihood of multimorbidity. Anticholinergic burden should be assessed in any patient who is prescribed one of these medications.
- If a burden is identified, dose reduction, deprescribing or switching treatments should be considered
- If the medication is required, choose an option with the least anticholinergic activity, and the lowest dose should be prescribed for the shortest duration.
