Report from the Board & CEO

Te Pūrongo a te Poari me te Kaiwhakahaere Matua

Tena koutou katoa,

We are pleased to present the 2022 Performance Report for the Little Miracles Trust. Looking back over the last 12 months, we are proud of the achievements of our team throughout 2022 in spite of the unique and ongoing challenges the pandemic presented. The stress and trauma felt by whānau having their little one in an intensive care unit is overwhelming without the added pressure of a global pandemic. Thanks to being recognised as an essential service and due to the close relationships with all 23 neonatal units, our operational team have been in the units and available to provide support when needed. This support ranged from face-to-face support of whānau through to the safe collection of expressed breastmilk from mothers isolating at home due to having Covid-19 and delivery of this to the NICU.

Our team has grown in terms of numbers which in turn increases the impact of the mahi we do. At the end of 2022 we had Family Support Co-ordinators based in all six tertiary units of Auckland, Middlemore, Waikato, Wellington, Christchurch and Dunedin. This is a significant change from the beginning of the year and signals the importance placed on our mission both by our generous supporters and the teams that work within the units who see us as an extension of their own team.

Following on from research undertaken in 2021, the Trust understood the need to grow awareness of its existence to a wider audience in Aotearoa NZ. The purpose of which is to raise the understanding and knowledge of premature and unwell babies in Aotearoa NZ, the experience of their whānau and to raise reliable funds in order to support them during such a difficult start to life. To gain nationwide traction and garner sustainable resources the Trust undertook an extremely successful rebrand which saw the creation of the Little Miracles Trust based on the strong foundation of The Neonatal Trust as it had been previously known. Since the change the Trust has received unprecedented support from the Aotearoa NZ media outlets, strengthened existing relationships with partners and gained a larger, countrywide following.



In addition to this, a number of 'firsts' were achieved by the team in 2022:

- our CEO, Rachel Friend, represented the Trust at the annual European Foundation for the Care of Newborn Infants (EFCNI) conference in Munich alongside 31 other global parent organisations. A great opportunity to network and understand the support available to parents around the world.
- we started our 'Listening & Sharing' webinar series where whānau have the opportunity to hear about and ask questions relating to topics close to their hearts such as baby's development and ongoing neonatal research.
- we were honoured to be the 'Charity Partner' for the Baby Show which enabled us to spread the awareness of the Trust's existence.
- our 'Lighting Up Purple' campaign saw over 40 iconic buildings and monuments light up purple in November for World Prematurity Day on 17 November.
- and we received a 'Highly Commended' award from the Fundraising Institute of New Zealand (FINZ) for our partnership fundraiser with HELL pizza in 2020, with FINZ noting that we're a small charity whose impact punches way above its weight.

Of course none of this would be possible without the unswerving support of our donors, grant-givers, corporate supporters, fundraisers and volunteers. Every single dollar and every hour invested in our cause makes a difference to what we can achieve. All our funding goes direct to supporting neonatal whānau; the 23 neonatal units; striving for advancements in neonatal medicine and the outcomes for the babies born unwell or too soon.

We thank you all for believing in the Trust, for the giving of your time and resources and look forward to another successful year with you in 2023.

These are the times you need someone who knows what you're going through to tell you it's going to be alright.

Someone who can give you the kind of support and resources that will make all the difference.

Someone who can say "We're here for you".




The Support We Provide

Te Āwhina ā Mātou

Every year approximately 10% of all babies are born premature (before 37 weeks gestation) in Aotearoa NZ. That's one premature baby born every 90 minutes. There are also full-term babies whose condition or illness requires admission to a Neonatal Intensive Care Unit (NICU) or Special Care Baby Unit (SCBU) after they are born. In all, over 5,000 babies have a difficult to start life in Aotearoa NZ each year.



We exist to support these whānau through a journey that can be full of stress and anxiety. This help is provided in a number of different ways, all aimed at “making a difficult start to life that little bit easier”

Onsite Support in the Hospital

We have a number of team members who work directly in the NICU units and visit the SCBU units on a regular basis. They are there for whānau to lean on during such a stressful time, with the majority of the team being ex-NICU/SCBU parents they are the perfect listening ear or shoulder to cry on. In addition to this we offer items such as breastpumps for hire and sale; prem baby clothing and nappies as well as lactation aids and lots of woollen goods handmade with love.

Care Packs

We supply around 5,000 care packs across every unit with one for to each whānau who has a baby admitted to a unit. These packs are made up of practical yet thoughtful items which will be of use during the whānau journey. There are many items we'd love to add (powerbank, antibacterial wipes or hand gel and water bottles for Mum), so if you would like to donate to help us with these packs you can [do so here](#).

Regular hospital lunches/morning teas

One of our most regular and popular support events is providing an opportunity for Mums and Dads with babies in the unit to meet and have a get together. This is an opportunity to provide necessary information and support and also answer any questions. Parents can also develop support networks with other parents, which help outside of the unit. Where facilities allow, the Trust host a regular light lunch or morning tea.

“This is just a fantastic gesture by the Trust and it was a great opportunity to chill out for half an hour with other parents over a piece of pizza and a cup of tea. We met two other couples whose babies were born around the same time as our son and we were all in the Unit for eight weeks so we got to know each other pretty well and compared notes about our respective experiences. We are now good friends with one of the couples in particular – that wouldn't have happened if we hadn't met at the weekly lunch – so we really appreciated it – thanks Little Miracles Trust!”

Unique Community Playgroups

Parents who have had a NICU or SCBU experience often need support once they return home, as returning home with a baby that was premature or sick can have demands over and above a full term healthy newborn. Plus they've gone from a busy hospital ward environment to being at home on their own.

Also parents may not have ever had the opportunity to join an antenatal group. We offer regular playgroups where parents can meet up after they have left the NICU and their babies can have a play.

They are unique as they are facilitated either by an Occupational Therapist or a Physiotherapist who is there to talk about baby's development milestones and give advice to the families.

Gifts for Special Days

We know how hard it is to be in an intensive care setting with your baby and this is felt even more on days of note such as Mother's Day, Father's Day and Christmas Day. So the team works closely with our partners to put together some thoughtful gifts for Mum, Dad or the family to be ready by baby's bedside when they visit on that special day.

Celebrating Baby's Milestones

We're all about celebrating how well a baby is doing during their time in a unit, so each family will get a set of specially designed neonatal milestone cards to help them keep a visual diary of these important days like when a baby hits the 1kilo mark or goes tube free! Plus we have a special '100 Day' certificate and bunting for those little ones who reach up to 100 days in hospital. And as each family gets to take their baby home we supply each unit with graduation certificates to give to complete and present to each family on discharge and there's a special selfie frame to capture the that magical moment.

Supporting the NICUs and SCBUs

We support the NICU and SCBU teams directly in a number of ways, for example, a good number of the chairs used for those all important kangaroo cuddles by Mum or Dad has often been supplied by us; vital training equipment such as the 'Baby Sim' simulation doll used for enhancing staff training; the privacy screens available to be able to close off a family's own part of a busy ward room; breastpumps available for use on the ward by Mum to express breastmilk for her baby; and we've helped with many refurbishments of parent rooms, kitchens and lounges.

Supporting the NICUs and SCBUs




Map of NICU's & SCBU's

Dion

Dion rode “Tour Aotearoa” - a 3,000kms bike ride the length of the country. It took him 26 days to complete, and he raised \$12,000.

“When I turned 50, I wanted to mark the occasion with something EPIC! As I am keen on anything with two wheels, I quickly realised that it needed to be on a bike. After researching various events around the world, I decided to keep it close to home, and settled on doing the Tour Aotearoa. This is a self-supported bike ride from Cape Reinga at the top of the North Island to Bluff at the bottom of the South Island.

As part of this epic adventure, I have the chance to raise some funds for a charity of my choice. As some of you may know our son came into the world 10 weeks early, weighing in at just 2lb 3oz. The support we received from neonatal support groups, such as the Little Miracles Trust, were invaluable to our journey and other parents around us.

Thankfully Zane is now 14 and every bit your normal teenager, but I will be forever grateful to the Trust and would now like to support them as my chosen charity.”

Amy

Amy is widely known as one of Auckland's leading newborn photographers. Specialising in creative newborn photography for over 15 years, Amy has been supporting the Little Miracles Trust for over 3 years by donating the \$49 sitting fee from all her newborn sessions for a beautiful baby book entitled “Tiny Fingers, Tiny Toes... Celebrating New Zealand's Babies”. This book is now into its 4th edition and Amy has raised over \$15,000 for our small charity, which is just amazing.

Amy says... “I've been photographing babies for over 12 years and have heard so many stories over that time from clients whose babies were in NICU. They raved about the support they received and were overwhelmed that their baby (or babies) was in many cases saved because of NICU. I've also heard many stories of the travel back and forth from NICU, the constant pumping and just the overall tiredness and stress that parents felt whilst baby was in NICU. The Little Miracles Trust is there to support those parents and make the time whilst baby is in NICU that little bit easier.

Photographing babies is a huge passion of mine and my happy place so it made sense for me to create a book doing what I love whilst also donating to such a worthy cause. The response I've had from clients has been amazing. They love that I'm supporting a cause that is so often dear to their own heart.

"We were so elated when our firstborn arrived back in 2015, he had been eagerly longed for, for 5 years. Things took a rough turn within the first few hours of his life when we were discharged to Birthcare and faced with the very real possibility of losing him. Ted had an undetected subgaleal hemorrhage and had to be resuscitated and urgently transferred back to NICU. The days that followed were frightening and traumatic. We will never forget the wrap-around care we received from the Little Miracles Trust. From the moment we arrived right through until discharge, they were there for us - even walking us to the door to cheer us on when it was time to leave."

Loretta dusted off her running shoes after 20 years and ran the Auckland marathon in January 2022. She raised \$3,570 for us after setting an initial fundraising goal of \$1,500.



Maryann

"Our daughter Skye was born at 39 weeks via an emergency c-section due to reduced fetal movement (the cause was unknown as my entire pregnancy was textbook) and weighed 2436 grams. Skye had suspected oxygen deprivation, kidney failure and many other health issues and was rushed from Hutt Hospital to NICU in Wellington. When I got transferred to Wellington for my recovery and to be reunited with Skye, the doctors said Skye would be in for the long haul. They prepared us with information and support that we would get from the Little Miracles Trust during Skye's suspected long stay. It was terrifying and overwhelming.

Skye was swimming in the newborn clothes I had packed in my hospital bag. I envisioned her wearing them in her first moments of being born. A small but very impactful thing was being provided with prem-size clothes for Skye and beautiful woollen hats that fit her tiny head while she was in her hospital cot. A small detail, like fitted clothes for our new baby, made a huge difference, and we were so thankful. Thankfully Skye spent seven days in NICU and then transferred to SCBU for three days before being discharged. Skye will turn two in March 2023 and is fully healthy and thriving. All these gestures and services provided by the Little Miracles Trust make a huge difference for families when their world is flipped upside down.

Since Skye was born, we regularly donate to the Little Miracles Trust. We will continue to do so because the support they provide is crucial. I shaved my hair for my birthday in December 2022 to help raise funds for the Trust. I set a very ambitious goal of \$1000, and with the support of my friends, whānau and even strangers, I raised \$3,100. Like many other parents, we never imagined or prepared for this start to our daughter's life. Knowing that the Trust's service is available for whānau that need it, makes a horrendous time that little bit easier."



- Jayden at The Edge raised \$4,000 for us by wearing a TENS machine.




SEPTEMBER

Thank you Little Miracles Trust, and specifically Diane, at the Auckland Hospital NICU branch.

My son was born at 27 weeks, and had quite a turbulent NICU stay. Over the 113 days he was there, he had multiple infections, a couple of surgeries, and looking back, we are so lucky that he is still with us.

During the hardest times of our lives, something that I will always remember was the support given to us by Diane and Little Miracles.

From the moment we arrived in NICU, Little Miracles brought a bit of light during hard times - little presents / gifts at the bedside, smiling faces each morning when we arrived at the hospital, a shop with all the things we may need, and the knowledge that they were there to support us and understand our journey.

When my husband and I got Covid and couldn't visit our boy, Diane was there reading to him each day. And the most helpful of all - the support group morning tea, where Little Miracles provided a supportive space for mum's to come together, eat tasty treats and listen to and share our stories.



The Little Miracles Trust showed me the most extraordinary support while my 10 week pre-term and small for gestational age (SGA), baby girl was in NICU.


Diane and Catherine from the Trust just made things happen around me.

It truly was a horribly challenging time with the burden made lighter by the wonderful ladies at the Little Miracles Trust, I don't know how I would have coped without their support.







Entity's Purpose or Mission

The Little Miracles Trust exists to make a difficult start to life that little bit easier for families of premature and or sick full-term babies as they make their way through neonatal care, the transition home, and onwards.

Entity Structure

The Little Miracles Trust is a registered charity in Aotearoa NZ (CC56619).

The Trust is governed by a board of trustees who meet and communicate face-to-face, over email and through the appropriate use of technology (phone-conferencing and video-conferencing).

The Trustees for the 2022 financial year were Mike Hartley (Chair), Sandra Budd (Deputy Chair), Karen Olver, Nicola Coom, Danielle Thompson, Robyn Voigt, Piyush Makan, Steven Allan, and Dale Garton. Ellen Benton and Acacia Cochise joined as trustees in March 2022.

The day-to-day running of the Trust is led by Rachel Friend as CEO, alongside a team of Family Support Co-ordinators spread throughout Aotearoa, as well as a Fundraising Manager and Operations Manager.

All of these roles are part-time with broad and collective responsibilities. These roles cover all aspects of our operation: governance, strategy, financial management, marketing, events, fundraising, volunteer management, developing support material, and more.

We are proud to have a model that is light on paid staff and heavy on volunteer commitment and support. The expert advice, skills and experience provided by our trustees, volunteers and supporters make a big contribution to keeping our operating costs down and helping us to better support neonatal families.

The wider neonatal and social profit community provides hundreds of volunteers who contribute with donating knitting, sewing, time with public collecting, design services, newsletter editing, baking and much more.

In addition to this, we receive wonderful support from a number of very generous organisations.

Main Sources of the Entity's Cash and Resources

The Little Miracles Trust receives its funding from a variety of different sources, including donations from the public and companies, fundraising events that we run ourselves plus those where we are the cause being supported and through grant applications.

The Trust does not receive any funding from the government.

Statement of Accounting Policies

'How did we do our accounting?'

The Little Miracles Trust
For the year ended 31 December 2022

Reporting entity

The reporting entity consists of the Little Miracles Trust ("Trust"). The Trust registered as a Charitable trust under the Charitable Trusts Act 2005 on 24 April 2019.

Basis of Preparation

The Little Miracles Trust has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting.

The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Revenue

Fundraising, grants and donations are accounted for depending on whether or not a "use or return" condition is attached to those grants.

Where no use or return conditions are attached, the revenue is recorded as income when the cash is received. Where income includes a use or return condition, it is initially recorded as a liability on receipt. The income is then subsequently recognised within the Statement of Financial Performance as the performance conditions are met.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

The Little Miracles Trust aims to hold the equivalent of six months average budgeted operating expenses plus a 10% buffer as cash reserves in the bank. These cash reserves have been purposely accumulated to provide a safety buffer for future service costs related to the paid roles within the charity and other operating costs.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are shown exclusive of Goods & Services Tax (GST), except for accounts receivable and accounts payable which are shown inclusive of GST.

Fixed assets

Fixed assets are recorded at cost less accumulated depreciation and impairment losses. Depreciation of fixed assets is calculated to write off the cost price of the assets at rates calculated to reduce net book value of the asset to its estimated residual value by the end of probable life.

This statement should be read in conjunction with the attached Compilation Report and notes to the performance report.

Depreciation

Depreciation is charged to the income statement at the same rate as allowed by the Income Tax Act 2007.

The following rates have been used:

Office equipment 40.0 - 60.0% diminishing value
Plant and equipment 7.0 - 67.0% straight line

Receivables

Receivables are stated at estimated realisable value. Bad debts are written off during the period in which they are identified.

Income Tax

The Little Miracles Trust has been approved as a charitable trust that qualifies for a tax exemption and donee status under Section CW 42 of the Income Tax Act 2007. Tax receivable balances are recognised when there is resident withholding tax due to be refunded.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

Contingent liabilities

There are no contingent liabilities at balance date. (2020: nil)

Description of Entity's Outcomes

The Little Miracles Trust has three objectives:

1. Supporting parents by helping them in whatever way we can to get through what is usually a very traumatic time, which includes providing practical, financial or emotional help.
2. Assist the NICUs & SCBUs in practical ways such as purchasing or contributing to the cost of equipment and furniture and funding for staff to attend neonatal educational seminars or other professional development.
3. Aid neonatal-related medical research.

Our support is provided to neonatal families in a range of different ways to reduce their stress and enhance outcomes for their babies. This included the delivery of Support and 'Pick-me-up' packs, sourcing and sharing of personal stories, development of support resources, and delivery of equipment for the neonatal units. In addition, we have helped to advance neonatal research through the sourcing of research participants and direct funding of research programs.

The last 12 months for the Trust has seen a real need for our support and reach due to families being separated from their babies during lockdowns, making an already difficult time even more stressful. We diversified our offering to be available for online support 24/7 and have necessary equipment delivered direct to families at home.

Additional Output Measures

While the numbers presented in this return are a guide, it is important to note the nature of our operation means that context to provide additional insight is useful.

We are an organisation light on paid staff (2 full time and 10 part-time staff) and heavy on volunteer commitment and energy.

The cost of these staff, and others on short term contracts (as required), and the necessary services and tools (storage, IT, courier costs, etc) enable a great deal of support. However, apart from the cost, much of the support activity is not captured in the financial accounts - as we are able to source donated items and services as 'value in kind'.
