

Treasurer Report 2025 Annual General Meeting

College of Respiratory Nurses New Zealand – NZNO

Financial Commentary

The College Provisional Financial accounts for the year ending 31st March 2025 show a net surplus of \$7,254. (This result is subject to audit changes that still are pending).

The College held its bi-annual symposium on 30 August 2024 in Auckland. The theme 'We are what we breathe – how environment impacts lung health' was very informative and inspiring thanks to our expert speakers. Feedback on the Symposium was very positive however the attendance for our symposium was lower the expected, and due to this it made a financial loss of \$1,704. Our thanks to the sponsors that attended the symposium and their financial contribution.

Income and Expenditure

The total income for the 2024/25 financial year was \$19,296 with expenses totalling \$12,042, resulting in the aforementioned net surplus after tax of \$7,254. This compares to a surplus after tax of \$3779.17 in 23/24.

This positive result is due to the following factors:

- Expenditure for 2024/25 was less than budgeted.
- Knowledge and Skills Framework review budget not utilised due to it having not yet commenced and not requiring face to face meetings to date.
- Grant expenditure has been less than budget due to less applications.
- Symposium income was less than budgeted for due to low numbers attending.
 Although this was a loss financially the symposium was a success for those that attended and from this point of view a successful day.
- Accommodation and meals for Committee meetings has been less than budget due to less overnight requirements.
- Annual accrued interest from term deposits.

Statement of Financial Position

The College of Respiratory Nurses ended the financial year on 31 March 2025 with cash at the bank (including term deposits) totalling \$95,146.33 compared to \$88,621.97 on 31 March 2024.

Our plan this year is to close the Savings account and put this money into a 12 month term deposit to accrue more savings annually.
