# **WHC Education Fund**

- Did you know that the Women's Health College has a small education fund of \$5,000 per annum available to assist members with ongoing professional development?
- Did you know that we never use the entire \$5000 set aside each year for members because we never get enough applications!?!



 Do you have an education or study day, a course or conference that you think will expand your knowledge and positively enhance your care of patients and their whanau?

### **Apply now!**

The applications are assessed quarterly at the Women's Health College Committee face-to-face meetings. While meeting dates vary, applications must be received by 1 February, 1 May, 1 July and 1 October each year.

## **Criteria for applications**

- Members must have belonged to the Women's Health College for a minimum of 2 years at the time of their application
- A College member can only apply for funding once every 3 years, i.e. a subsequent application will only be accepted for review 3 years after the date of the previous application.
- \$400 per person is the maximum contribution
- Retrospective applications cannot be accepted
- Funding goes to the person who applied and cannot be transferred to another person
- All successful funding recipients must write a short report about what they learned on their education/conference/course, and how it has improved their practice and send it to the College. This report will be published in a subsequent Women's Health College newsletter.

# **Regulatory Assurance Team – Abortion Services**

The Regulatory Assurance Team Manager Rob McHawk, and Senior Analysts, Meryl Fraser and Andrea Babel from the Ministry of Health (MOH) spoke to the WHC committee about the new team of six at MOH, who have oversight and monitoring of Abortion Services (amongst other things) in NZ.

The work streams for Abortion services are:

- Stakeholder engagement and communications
- Policy, Legislation & Ministerial engagement
- Abortion services standards and regulations
- Medicines and medical devices
- Service design and implementation (models of care / pathways)
- Workforce
- Consumer information
- Data collection and reporting
- Funding and accountability

They are keen to understand from the WHC

- The key issues / concerns /risks that these changes have created for our profession?
- What plans do our organisations have to address these issues?
- What support is required from the MoH?

We also had a robust discussion about women now having access to post 20 week abortions, and the work force issues associated with this, and other brief discussions from the committee about some e.g. Nurses not being able to request Ultrasounds.

## Nurse Hysteroscopist Training

The WHC has begun the journey of developing the training standards for nurses to do hysteroscopies in New Zealand, just as it successfully did for Colposcopy.
